HOW TO DONATE VEHICLES

Questions:

Does my vehicle have to be running to qualify for a donation? Yes, the vehicle must have an engine, must run normally and be safe to operate. In some cases it must be towable. However, vehicles that are in extremely poor condition or far from our tow area may cost more to tow (or transport) than the value of the vehicle. If this is the case, PWHBC may not receive any dollars from your vehicle.

What paperwork do I need? A signed title (pink slip) is required for donation. Do not fill in the "sold to" section. If the title is not available, you'll need to submit an Application for Replacement Title with the DMV and contact us when you have the replacement title. The vehicle's registration card and keys should also be given to our representative.

Do I get a receipt for my donation? Yes, our driver will issue a receipt at the time of pick-up. This is not your final tax receipt. The initial acknowledgement will indicate your name and the year, make and model of the vehicle you are donating.

A final acknowledgement will be mailed to you within 30 days of the sale. The amount of gross proceeds received from your vehicle will be listed on this receipt. This will be your receipt for your charitable contribution.

What can I claim as a deduction? Due to recent IRS updates to the rules regarding vehicle donations and the amount of the deduction that can be claimed, we recommend that you refer to IRS Publication 4303 "A Donor's Guide to Vehicle Donations," which can be found at www.irs.gov, or contact your tax advisor to determine the amount of your tax deduction.

What does PWHBC do with the donated vehicles? The vehicles are sold usually at auction. The funds from vehicle donations are used for community outreach efforts to other charitable organizations, for individual needs programs, school sport programs and various other service organizations in our community.

Do I have to be with the vehicle at the time of pick up? No. Special arrangements can be made when we talk to you.

How much money does PWHBC receive? It varies. However, after pick-up or towing and administrative costs we will receive the remainder of the proceeds from the sale of the vehicle.

Do you accept "Salvage Vehicles?" Unfortunately, there is usually too much involved in disposing of "salvage vehicles" that we would not receive even a minimum amount of money; we could even lose money and that is counter productive.
